# Our Experience with Climate Change and Support in Crisis Situations

All over the world, climate change is creating challenges for people with intellectual disabilities. During an emergency we need better support to stay safe and independent.

We are often excluded from humanitarian response because organizations do not understand the help that we need.

"Humanitarian organisations often don't understand what intellectual disability is. There are humanitarian activities for people with disabilities but they are often inaccessible to people with intellectual disabilities."

### **Our Rights**

Article 11 says that governments need to work to keep us safe during emergencies, including climate disasters.

**Big Problems We Face** 

#### Discrimination

- Humanitarian organizations do not understand intellectual disability
- We face discrimination from other people when we try to get help
- We are not included in conversations about climate change and disasters

#### **Accessible Information**

- We don't have access to accessible information about the disaster
- Humanitarian workers don't know how to talk to us


"[Aid workers] asked us [what we need], they just registered our name to provide, to give us some support. But they didn't give us that support."

### **Inclusive Humanitarian Response Looks Like...**




- We get clear information about what is happening in emergencies

# What Governments and Humanitarian Organizations Can Do

- Make Accessible Information
  - Create warnings that everyone can understand
  - Use different ways to tell people about emergencies
- Provide Inclusive Services
  - Train emergency and humanitarian workers to understand the needs of people with intellectual disabilities
- Listen to People with Intellectual Disabilities
  - Include people with intellectual disabilities in discussions on climate change and emergencies
  - Respect Organizations of Persons with Disabilities
  - Support climate projects led by people with intellectual disabilities
