

Consent Form

This is a consent form.

“Giving consent” means agreeing that it is okay to do something.

This consent form is about sharing information about your life.

It is something you need to read and agree to before you take part.

There is information about why we are asking for your consent below.

What am I being asked to do?

- You are being asked to take part in an interview to talk about your experience.
- The interview is all about what it is like for children with disabilities who need to move to a new place because of a crisis.
- The questions will be about what it has been like for children trying to go to school in a new place.
- Children with disabilities and parents of children with disabilities will take part.

Who is asking me to take part?

- Inclusion International and the International Disability Alliance are collecting this information. They are two organisations that are run by people with disabilities.
- They are getting money to do this from ECW, which is a group that wants to make education in emergency situations better.

Why is this information being collected?

- Inclusion International and the International Disability Alliance care about children with disabilities who are living through crisis.
- They are doing a big project that will try to make sure children with disabilities are included in education in emergencies.
- To help make things better, they want to understand what your experience has been like. They will hear from parents and children about what needs to change.
- Then they will make tools and information for big organisations about how to better include children with disabilities in education in crisis situations.

How will what I tell you be used?

- Inclusion International and the International Disability Alliance will use the information you share to make resources for other organisations to use. These resources will help make sure children with disabilities are included at school in emergency situations.
- Information you share can be used in different ways. For example, they might use the things you say need to change to tell other organisations what to do. Or they might use a story you tell them to explain why something needs to change.
- None of the information we use about your experience will be able to be connected back to you. We will not use your name, or any information that would make it easy for someone to figure out who you are. This is called being “anonymous.”
- The only people who will hear the recordings of your interview are the project staff. After the notes about what you said in your interview are done, then the recording will be deleted. This is part of making sure that you are “anonymous.”
