Sessions about Closing Institutions

These sessions are about closing institutions.

Institutions are places where people with intellectual disabilities:

- are separated from the community
- live together in groups
- do not have control or choice about their lives.

The Survivor's Network: How people who lived in institutions are working to shut them down

Hosted by Inclusion International

The Survivors Network is a group at Inclusion International for selfadvocates who lived in institutions before, but now live in the community instead. In this session, survivors of institutions from around the world will talk about their stories, and why it is important to work together.

Closing Doors, Transforming Communities

Hosted by the Canadian Institute for Inclusion & Citizenship

People with disabilities and their families used the courts to force the province of Nova Scotia in Canada not just to close its institutions, but to make big changes to the way people with disabilities are supported. This session will share how the court case has changed what inclusive communities look like in Nova Scotia, and what other communities can learn from it.

Closing an Institution: Real Stories from Survivors and Professionals

Pushing Back Against Assisted Dying/Euthanasia for People with Disabilities

In some countries, laws have been changed so that having a disability is a reason for someone to access assisted dying (euthanasia). Learn how to advocate against the expansion of these laws to protect the rights of people with disabilities - based on lessons from Canada's experience.

This session is about different types of easy to understand formats - like easy read, accessible videos, and other ways to make information easier. We will talk about how different formats can be used in different ways.

Hear experiences from Sweden and Finland about work for real inclusion of people with complex needs. Through personal stories, films, and lived experience, hear about how self-advocacy, family support, and personal assistance make independent living and full participation in society possible – even for those with the most highest support needs.

Crisis situations could be things like a war or a flood. These things often mean people have to leave their homes.

People also call this a "humanitarian situation."

This session will talk about why inclusive education is important in places affected by crisis. It will also share experiences from Inclusion International members who work on education in crisis situations.

Young girls with intellectual disabilities are not included in crisis situations. This session will talk about work done in Ethiopia and Burkina Faso to find out what girls need in crisis. It will shape recommendations for what humanitarian organisations can do differently.

Big international development projects usually don't include people with intellectual disabilities and their families, but this session will talk about how we can do things differently. Hear examples of projects that used inclusive ways of working to make sure everyone was included in development work.

Together for Inclusion – collaboration between Organisations of Persons with Disabilities (OPDs) and NGOs

This session will share how organisations of persons with disabilities (OPDs) and other organisations (NGOs) can work together well, sharing the example of the Together for Inclusion (TOFI) Project. It brought together organizations of people with disabilities in Norway and some of the country's biggest and most trusted NGOs. They worked as a team to support people who are often left out, by helping to build strong organizations, promote disability rights, improve access to education, and create job opportunities. The speakers will talk about what they learned from working together on this project.
